THE MATTABASSETT DISTRICT TRUNK SEWER LINE EVALUATION

RFQ SOLICITATION #2018-12

Prospective Consultants and all concerned persons are hereby notified of the following changes to the above referenced Solicitation:

1. Section IV.(a)4 of RFQ 2018-12 states: "*The selected firm must meet all Town, State and Federal affirmative action and equal employment opportunity practice. The Consultant's published statement as such shall be included in the RFQ.*" Does the Consultant need to comply with Connecticut General Statutes (C.G.S.) 4a-60, 4a-60a, 4a-60g, 46a-68b-68f, as amended by Special Session Public Act 15-5 in 2015? In other words, does 25% of the total value of the contract be set-aside for a certified Small Business Enterprise (SBE), of which 6.25% must be awarded to a certified Minority Business Enterprise (MBE) or Woman-owned Business Enterprise (WBE)?

Answer: No, this does not apply to this Solicitation.

2. Is funding for the project is currently in place?

Answer: yes

3. The last page of the table listing the pipe is small diameter pipe we understand to be the connections to the Trunk Line. Are any parts of these pipe segments part of the evaluation project?

Answer: These are municipal meter connections to the District's trunk sewer and are owned and maintained by the District's member towns. The District is requesting Consultant Qualifications only under this Solicitation. The selected qualified consultant will recommend and develop the scope of work which may or may not include evaluating these meter connections.

4. For the trunk sewer line evaluation work under RFQ 2018-12, are as-built drawings of the pipeline available for viewing?

Answer: yes. Plans are available at the Mattabassett District Administration Building located at 245 Main Street, Cromwell. Please email Michelle Ryan, P.E., at mryan@mattdist.org, or call (860)635-5550, ext 205, to schedule to come in to review the drawings.

5. Does the District anticipate applying for any State or Federal Funding for this project? (which will determine if MBE/WBE participation is required).

Answer: No, at this time we do not anticipate any State or Federal funding for this project. However, depending on the extent of the rehabilitation work is developed under this project, this may change.

6. Does PA 15-5 apply to this project?

Answer: No, this does not apply to this Solicitation.



In Section III, Nature of Services, Item No. 1, (regarding the minimum assessment under this Solicitation to include), states, “ Establishing location of the existing system, with GPS mapping, to be delivered to the District in both approved electronic format, as well as hard copies”. Can you please provide clarification on the extent and level of detail required for Task 1: “establishing location of the existing system”?

Answer: The District is requesting Consultant Qualifications only under this Solicitation. The selected qualified consultant will recommend and develop the scope of work.

8. **Cyber Liability Insurance will not be required for the work under this RFQ.**
9. **The District will accept Professional Liability Insurance on a claims made basis, with the rest of the insurance limits on a per occurrence basis, provided the coverage amounts meet the District requirements and the insurance is in force during the period of performance.**
